WOODVALE PROGRESS ASSOCIATION INC. STATEMENT OF PURPOSES

Goal:

To facilitate the exchange of information of relevance to the Woodvale community members, and to support strategies which are in accordance with the documented planning guidelines and the stated wishes of community members.

Objectives:

- To provide a forum for the exchange of information and views which enables Woodvale community members to make informed decisions about issues affecting the locality.
- To provide a forum for the presentation of expert advice to community members.
- To develop, implement and monitor an annual action plan derived from the Woodvale Community Plan.
- To represent the wishes of Woodvale residents, and to be the voice of the community in providing advice to local government, government authorities and private enterprise about matters affecting the community.
- To promote positive community spirit, and support activities and groups of benefit to Woodvale and its people.

Membership:

In addition to membership requirements set out in the 'Model Rules for an Incorporated Association' under the 'Associations Incorporation Reform Act 2012', the following requirements apply:

Eligibility for Membership:

Eligible members must be currently a resident of Woodvale, or have direct personal or commercial links to Woodvale, or singularly represent an organisation or club in Woodvale (*one organisational vote per motion*).

Life Membership:

Upon recommendation of the committee, the Association may in general meetings elect a life member; any person who, in its opinion, has rendered outstanding service to the Association.

A life member shall:

- Be entitled to attend regular meetings of the Association.
- Be entitled to vote.
- Be entitled to receive notice of meetings.
- Not be required to pay any subscription or levy to the Association.

A person elected as a Life Member may consent to that election, and then shall be bound by the rules of the Association. If that person does not consent within 28 days of the election as a Life Member, that election shall be deemed to be of no force or effect.

Associate Membership:

Associate Membership shall be available to persons who wish to support the Association in principal and financially, but are unable to attend a minimum of one in four meetings as required in the 'Model Rules for an Incorporated Association'. Associate Members share all rights with full members except for the right to vote.

Committee of Management:

In addition to office bearers, all financial members of the association (including life members) are considered and treated as ordinary members of the 'Committee of Management'.
